In 2008, Air, Soil and Water Research was launched as open access, peer-reviewed international journal covering all areas of research in soil, air, and water. Parallel to the development of new monitoring and modelling techniques, an interesting scientific change can be observed in the titles published in the journal during the last 10 years related with the significance of interactions between air, soil, and water spheres. This trend fully agrees with the new scientific paradigm to promoting integrated, multidisciplinary, and collaborative investigation.

The manuscripts published during the last 10 years cover a variety of highly significant topics including the United Sustainable Development Goals Intergovernmental Panel on Climate Change, among others. Several of the articles published in our journal add significant new insight into global environmental challenges at regional, catchment, urban/rural, hillslope, or pedon scales.<sup>1,2</sup> Also, numerous authors have agreed that the interaction between the air, soil, and water spheres has been drastically influenced by humans.<sup>3-5</sup> However, much work is needed in the field of air, soil, and water analysis, including topics such as microbiology, chemicals and pollution, consequences for plants and crops, soil hydrology and erosion, climate change, and consequences of change, social issues, remediation, pollution cleanup, and more. Although much has happened in the past decade, we look forward to the changes we will surely see in the next 10 years.

As part of the evolution in the last decade, we are happy to share that the journal is now divided into 3 sections to streamline the peer review and decision-making process. Each of the 3 sections is handled by a Section Editor: Dr M.T.L. (air), Dr J.R.-C. (soil), and Dr E.R.B. (water). Moreover, the journal is supported by a list of highly international experienced researchers, which can be viewed on the
