Caribbean Journal of Science Guidelines for Authors (January, 2024)

The Caribbean Journal of Science (CJoS) publishes original research relevant to Caribbean natural sciences. The emphasis is on botany, zoology, ecology, conservation biology and management, archaeology, geology, and paleontology. The journal is published online at BioOne.org. There are no charges to authors. Consult a recent CJoS issue for additional details and examples on format and style.

Manuscript Preparation

Manuscripts should be submitted as a Word document and arranged as follows: title, authors, abstract, text, acknowledgments, literature cited, tables, figures and their captions, and appendices. An institutional affiliation should be provided for each author, and an email address, ORCID ID, or some other unique author identifier can be provided for each author, with one author indicated as the corresponding author.

Abstract—The abstract should include the purpose of the research, the main methods used, the most important results, and the most significant conclusions. All articles must have the abstract in English, and may include the abstract in another language.

Text—Main headings (Materials and Methods, Results, Discussion, etc.) should be centered. Secondary headings within these may be listed. The authority should be provided for all scientific names of species following the appropriate nomenclature code. The family can be listed for genera or species. The International System (SI) is used for all units and measurements. Cite references by author and year. In the literature cited section, list all authors for each reference. All references included in the literature cited section must be cited in the text, and vice versa. Use these styles:

Tables—Tables should be included within the Word document. The table heading should include all of the information needed for interpreting the table.

Figures—Figures can be one or two columns. Captions should be submitted separately from the figures as text. Submit all figures within the Word document initially. Once a manuscript is accepted, please submit the figures as tiff or jpeg files at high resolution.

Manuscript Submission

Submit a single Word document containing the text, tables, and figures. Send the manuscript to editorcjs@uprm.edu. In the email message please indicate that the manuscript is an original contribution and is not under consideration for publication elsewhere. Suggestions for reviewers are much appreciated.
