English is the official language of the Bulletin. Please take careful note of instructions to authors (available online at https://www.iczn.org/ submitting-to-the-bulletin-of-zoological-nomenclature/submitting-to-bzn/) as incorrectly formatted applications will be returned to authors for revision. The Commission's Secretariat will, where possible, answer general nomenclatural (as opposed to purely taxonomic) enquiries and assist with the formulation of applications and, as far as it can, check the main nomenclatural references in applications. Correspondence should preferably be sent by e-mail to iczn@nus.edu.sg.

(2) The Commission votes on applications eight months after they have been published, although this period is normally extended to enable comments to be submitted. Comments for publication relating to applications (either in support or against, or offering alternative solutions) should be submitted as soon as possible. Comments may be edited (see instructions for submission of comments at https://www.iczn.org/ submitting-to-the-bulletin-of-zoological-nomenclature/submitting-to-bzn/case-comments/).
