### **Correction on terminology**

An error occurred in the paper entitled "Metastatic carcinoma of probable transitional cell origin in 66 free-living California sea lions (*Zalophus californianus*), 1979 to 1994" by Gulland et al., in the April issue of the *Journal of Wildlife Diseases* (Volume 32). In the last sentence on page 253, the word "cytokine" should be replaced by the word "cytoskeletal." The sentence should read as follows: Immunohistochemical studies using a panel of cytoskeletal stains confirmed the neoplastic cells as epithelial in origin.
